IX. <u>General Provisions:</u> The following Provisions are incorporated into this document_in full force and effect.

GENERAL PROVISIONS FOR SUBCONTRACTS UNDER NSF GRANTS TO UNIVERSITY OF PUERTO RICO, MAYAGUEZ CAMPUS

1. PAYMENT:

Invoices should cite Purchase Order No. 534574. One invoice will be sent for the prepayment of the first year of work corresponding to this contract and will be described according to the first year of the NSF UPRM-NDSU budget given in Attachment 2. The Second invoice should be send for prepayment of the second year of work and will be sent during the second year of the contract and will correspond to the second year of the NSF UPRM-NDSU budget. Two (2) copies of these invoices, detailing current charges and total-to-date charges, should be sent to the principal investigator for processing at the UPRM Research and Development office. Work will be performed as scheduled in Attachment 1

2. ALLOWABLE COSTS:

The amount authorized will cover the direct costs of the research and whatever indirect costs are allocable thereto. The allowability of costs will be determined in accordance with applicable NSF cost principles.

3. LIMITATION OF COST:

The Subcontractor shall not be reimbursed for costs incurred in excess of the total amount allowed without an amendment to this Subcontract. The Subcontractor shall not be obligated to continue performance beyond the point at which the Subcontract funds expire. The Subcontractor shall notify the UPRM Administrative Officer at any time it anticipates that, within 60 days, funding will be insufficient to accomplish the purposes of this Subcontract.

4. AUDIT:

Subcontractor agrees to provide UPRM with copies of any of the independent auditors' reports which present instances of noncompliance with federal laws and regulations which bear directly on the performance or administration of this Agreement. In cases of such noncompliance, Subcontractor will provide copies of responses to auditors' reports and a plan for corrective actions. The Subcontractor shall cooperate with UPRM in resolving questions UPRM may have concerning the auditors' reports and plan for corrective action.

5. GRANT-RELATED INCOME:

The Subcontractor will inform UPRM of any grantrelated income and will maintain appropriate records for the receipt and disposition of such income to enable UPRM to fulfill its responsibility to NSF. The Subcontractor agrees to utilize such income as prescribed by NSF.

6. CHANGE OF PROJECT DIRECTOR:

The Project Director may not be changed, nor may his/her effort be substantially redirected, without approval by UPRM. If the Project Director should become unavailable to the project for a period exceeding three (3) months, the Sub-contractor shall, upon receipt of UPRM approval, appoint a replacement.

7. PRIOR APPROVALS:

The administrative requirements for approval of rebudgeting will be governed by NSF Policy. Approval requests related to the aforementioned would be reviewed and, if appropriate, approved by UPRM administrator or, if appropriate, forwarded to NSF for approval.

8. EQUIPMENT

In accordance with NSF requirements, except for equipment defined as Government Furnished Property, the Subcontractor will retain title to all equipment purchased under the grant. The Subcontractor agrees to maintain sufficient records to enable UPRM to fulfill its accountability under the NSF grant. The Subcontractor shall submit a final report of Government Furnished Property or equipment purchased under the subcontract to the UPRM Office of Research Administration within thirty (30) days after the expiration date of the subcontract.

9.PATENTS:

The determination of the rights of ownership and disposition of inventions resulting from the performance of the work under this subcontract and the administration of such inventions shall be in accordance with NSF policy. If the Subcontractor decides it will not take title to any such invention, it will so notify UPRM and provide such information as may be needed and requested by UPRM to permit UPRM to petition the Government for title.

The subcontractor shall provide such notice to UPRM at least two (2) months before it informs the Government that it elects not to take title.

The Subcontractor will insure that the terms of this subcontract and NSF policy are agreed to by all persons who perform any part of the work under this subcontract and who may be reasonably expected to make inventions.

The Subcontractor shall submit a final report of inventions within thirty (30) days after the expiration of the sub-contract to the UPRM Office of Research Administration.

No human subjects are to be used in the conduct of the research. Violation of this agreement will close the contract.

11. CIVIL RIGHTS AND EQUAL EMPLOYMENT OPPORTUNITY:

10. HUMAN SUBJECTS:

The Subcontractor shall comply with Title VI and VII of the Civil Rights Act of 1964, and Executive Order 11246 and certifies that it has a valid Assurance of Compliance on file with the National Science Foundation. The Subcontractor agrees to include in any contract entered into pursuant to this Memorandum of Agreement paragraphs (1) through (7), Part 11, Subpart B, Section 202, Executive order 11246.

12. TERMINATION:

13. PUBLICATIONS AND REPORTS:

UPRM may terminate this agreement upon written notification to the Subcontractor who, in the event of termination, will be reimbursed for any non-cancelable obligations properly incurred prior to the date of notice of termination. Funds not used will be reimbursed to UPRM with the necessary records to verify expenses.

The Project Director is encouraged to publish the results of his/her research. NSF support should be acknowledged as Follows: "This investigation was supported by NSF Research Grant No. 0082832. Reprints should be provided to the UPRM Principal Investigator. A renewal proposal, with appropriate institutional approvals, together with a progress report should be submitted at the request of the UPRM Principal Investigator in sufficient time to permit inclusion in the grant renewal proposal if applicable. During the final year of the subcontract project, the final report shall be submitted to the UPRM Principal Investigator no later than thirty (30) days before the NSF due date.

14. COPYRIGHT:

The author(s) is free to arrange for copyright without approval when publications or similar materials are developed from work supported in whole or in part by this subcontract. Any such copyrighted materials shall be subject to a royalty-free, non-exclusive, and irrevocable license to the U.S. Government to reproduce them, translate them, publish them, use and dispose of them, and to authorize others to do so.

The Subcontractor shall, to the extent of its liabilities under the laws of Puerto Rico, indemnify, defend and save harmless UPRM from any and all loss, damage, claims, actions and suits whatsoever including all costs, expenses, and attorneys fees incurred by the Subcontractor on behalf of UPRM in connection there with that arise out of the Subcontractor's negligence or other legal wrong-doing in any way connected with activities under this subcontract. UPRM agrees to give the Subcontractor immediate notice of any claim, action or suit in any way connected with activities under this subcontract. The Subcontractor expressly retains its rights to recovery from UPRM in the event of adjudication by a court of competent jurisdiction if: (1) the Subcontractor and UPRM are jointly liable for loss or damage to a third party, (2) the judgement against UPRM is based upon its sole and direct liability. The Subcontractor agrees to maintain its normal insurance coverage during the course of this agreement.
